## Introduction

The D 7 visa is a residence visa specially established for foreign senior citizens, religious people, and pensioners also those persons who want to live in Portugal after retirement as well as on the income from movable assets, real estate, or financial investments. This visa is indented to attract retired people with stable income in Portugal. The monthly income should be higher than 635.00 euro per month. On the behalf of such visa; applicant also can make the request of residence permit of their family members as well. D7 visa should apply to Portuguese consular in his/her country, after successful visa application, visa issued for four months and in this period candidate can enter in Portugal and will be eligible to apply residence permit. This residence permit will renew after one year & again more two years then after five years, applicant becomes eligible for applying Portuguese Nationality.

## Minimum passive income require

<b>1.</b>	Primary	635.00 Euro	6 months
<b>2.</b>	Secondary (Spouse )	50% of the minimum wage in 2020	6 months
<b>3.</b>	Dependent (children)	30% of the minimum wage in 2020	6 months

## Documents required:

- Original passport valid for an additional three months
- Two passport size photographs
- Travel insurance
- Portuguese criminal record clearance
- Police clearance certificate with the apostle
- Proof of sufficient funds, i.e., bank statements for the last six months
- Income tax returns for the last three years.
- Proof of passive/stable income

### **For the religious applicant:**

- Applicant document proving that is part of a religious organization that is recognized by the Portuguese Government.
- Guarantee letter from religious organization with confirming accommodation & payment of all living expenses.
- In case of retirement, a document certifying retirement amount

### **For people living out of personal revenue:**

- The document is certifying income from movable and immovable property or financial assets.

## Recommendations (not Obligation):

- Exploratory visit before process the D-7 visa application
- Registration with tax and social office at Portugal as NHR
- Open an bank account in Portugal
- Confirmation of accommodation booking (Junta)
- Deposit or transfer amount in Portuguese bank
- Establish strong connection and reason for live in Portugal
- Passive Income from reliable sources as such government bounds ,rental ,pension ,bank fixed deposit interests etc.

- Visa-free travel entire Schengen area
- Freely live and work in Portugal
- Residence permits acceptable as non-habitual resident
- Right for social life in Portugal as such medical, education unemployment benefits
- Tax benefits
- Family accompany
- Nationality apply after five years.
- Processing time 30-90days maximum
